Image Advertising Service LLP-Privacy Policy

Please read this Privacy Policy very carefully (along with the Terms of Service and Community Guidelines together called the "Terms"). This contains important information about the privacy of Your information and data with respect to the use of Image Advertising Service LLP Platforms and services connected with it. This Privacy Policy applies to Image Advertising Service LLP's mobile or desktop application software technology ("Platform" or "Services" or "Image Advertising Service LLP"), and services offered by Image in connection with the Platform. By using or by registering Your profile with the Platform and/or by using Services offered in connection with the Platform. You are consenting to the use, collection, transfer, storage, disclosure and other uses of Your information in the manner set out in this Privacy policy. For the purpose of this policy, any reference to Image shall include its business associate(s), affiliates, subsidiaries and sister concerns.

This document is published in accordance with the provisions of the Information Technology Act of 2000 read along with its relevant rules including Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011 and Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 and amendments if any.

We are committed to protecting your privacy. This Policy explains our practices concerning the personal data we collect from you, or that you provide to us. If you do not agree with this policy, you should not use the Platform.

This Privacy Policy does not apply to the practices of third parties that Image does not own, control, or manage including but not limited to any third-party websites, services, applications, or businesses ("Third-Party Services"). Image does not take responsibility for the content or privacy policies of those Third-Party Services. Image encourages You to carefully review the privacy policies of all Third-Party Services You access through the Platform.

This privacy policy is subject to the Platform's Terms of Service.

If You do not agree with any of the provisions of this Privacy Policy, You may not download, install and/or use the Platform and/or Services. Image may revise, alter, add, amend or modify this Privacy Policy at any time by updating this page. By updating, downloading, installing and/or continuing to access/use this Platform, You agree to be bound by any such alteration, amendment, addition or modification.

1. Privacy of Users

Image takes the privacy of its users seriously and exercises best efforts to protect their private data/information. Image endeavours to provide a secure and reliable environment for using its Platform and Services. Any private information collected by Image from You will be used only in accordance with this Privacy Policy and the terms and conditions provided hereunder.

This Privacy Policy sets out what information Image collects from You, how that information may be used, how the information will be protected, and what choices You have as a user. You are advised to read the policy carefully and provide Your consent only if You agree with the terms of the Policy.

2. What information may be collected by Image

Image collects information to provide better services to all our Users – from figuring out basic stuff such as which language you prefer, to more complex things like which ads you'll find most useful, the information matters the most to You online. The information Image collects, and how that information is used, depends on how You use our Services and how you manage Your privacy controls. Image may collect information from Users at various stages from registration on the Platform by the Users to submission of content by the Users or while the User is accessing/using Services. The information collected may be personally identifiable information or other information. You may choose to not provide the information if You do not wish to use the Platform and/or Services.

2.1. Personally Identifiable Information

2.3. Subscription or Paid Service Data

When you choose any subscription or paid service, our payment gateway provider/payment system provider may collect your personal information such as address or billing information, including your credit/debit card number and expiration date etc. The subscriptions or paid Services may be on auto renewal mode unless cancelled under applicable regulations. If at any point you do not wish to auto-renew your subscription, you may cancel your subscription before the end of the subscription term or contact Us on <u>info@imageservices.in</u> with subject "Billing/Subscription" and relevant information for Us to process your request.

2.4 Transactional/ Billing information

Based on your purchase of a subscription or paid service, Our payment gateway partner may collect information, including but not limited to, your credit/debit card details or other bank account details along with your billing address. This information is stored by the payment gateway partner. 3. How Image uses the information collected

Image may collect and use Your personal information and other information for business and/or non-commercial purposes. Image may use the information for the following purposes:

3.1 We use information to provide you with services and administer our websites and apps. For example We might also use your information to send push notifications on our Platform and to notify you about content you might be interested in or activity updates. We use information as otherwise required or permitted by law, or as we may notify you at the time of collection.

3.3 We may use personal information to create identified or aggregated data which does not identify you or any other individual, or from which your identity cannot reasonably be ascertained. We may use and disclose de identified, anonymous or aggregated data as we choose.

3.4 Image may use Your non-personal information like information regarding third-party apps, including without limitation, package name (which is same as the package id on play store), package version, installation and/or uninstallation event information for personalizing contents and Services based on Your interests. Image may also use Your non-personal information for promoting content with respect to, or from other applications installed or used by You or for creating customized sharing options for You.

Image may also use Your Information for market research purposes and may share Your Information with its affiliated businesses that it controls (including Image Infotech). Image may also use Your information for targeted advertising, targeted content delivery, and other business purposes unless You specifically opt out of such uses. 4. How Image protects User information and Retention of Information.

4.1 Image products and Services are built with strong security features that continuously protect Your information. 5. Control Over User Information

We want you to be in control of your personal information, in accordance with the terms of use:

- Access, Correction, and Portability. You can access and edit your account information right on our Platform. Because your privacy is important to us, we will ask you to verify your identity. We may also reject your request to update your personal information for a number of reasons, including, for example, if the request risks the privacy of other users or is unlawful.
- Revoking permissions. In most cases, if you let Us use your information, you can simply revoke your permission by intimating Us as per the due process for revocation laid down by Us.
- Deletion. 6.2.
